AirMembrane, which develops mass production technology for high-quality single-layer graphene, raises 100 million yen in seed round

About AirMembrane Co., Ltd.

AirMembrane Co., Ltd. was founded in 2017 based on the results of graphene research at the National Institute of Advanced Industrial Science and Technology (AIST). Graphene is a single-layer carbon allotrope in which carbon atoms are arranged in a planar manner, and its excellent conductivity and responsiveness are expected to be applied to next-generation devices. However, high-quality single-layer graphene has not yet been used as an industrial material due to the difficulty of its production. AirMembrane is taking on this challenge and developing mass production technology that dramatically improves the quality and production efficiency of graphene production. Our single-layer graphene film can be transferred to a wide range of substrates that other companies cannot handle, and is expected to be applied in advanced technology fields such as transparent electrode films and ultra-sensitive sensors.

Future Outlook

With the funds raised in this round, AirMembrane plans to improve its mass production technology for high-quality single-layer graphene and promote the recruitment of personnel to expand the company's products. In addition, we will accelerate our expansion into overseas markets, including the United States, in addition to the domestic market, and aim to become a leading company in the global graphene market.
